

EGGO™ DAYLIGHT SAVING TIME SWEEPSTAKES

OFFICIAL RULES

1. **PROMOTION DESCRIPTION.** The *Eggo*™ Daylight Saving Time Sweepstakes (the “**Sweepstakes**”) is an online entry only Sweepstakes that begins on 3/9/23 at 12:00:00 AM Eastern Time (“**ET**”) and ends on 3/12/23 at 11:59:59 PM (ET) (the “**Promotion Period**”).
2. **ELIGIBILITY.** Open to legal residents of the fifty (50) United States and District of Columbia who are eighteen (18) years of age or older at the time of entry. Limit one (1) entry per person/email address during the Promotion Period. No automated entry devices, bots and/or other programs and/or software are permitted for entry. No mechanically reproduced, altered, forged, or facsimile entries will be accepted. All entries become the sole property of Sponsor and will not be returned. Sponsor is not responsible for lost, late, illegible, incomplete, invalid, unintelligible, misdirected, technically corrupted or garbled entries, which will be disqualified, or for problems of any kind, whether mechanical, human or electronic.
